All wines for the Dinner, Wine Auction and Wine Masterclasses will be donations from the Vintner friends of N K Yong and Melina, and will be flown in directly from their cellars. Some Auction items will also come from local wine-lover friends.

There will be over twenty-five (25) famous wine-growers, some accompanied by their spouses attending the Gala Dinner and Auction and taking part in the Wine Masterclasses. ABOUT ST. ANDREW'S AUTISM CENTRE (SAAC)

An integrated centre for the education, training and care of persons with autism and their families, SAAC presently operates a special school for children and youths with moderate to severe autism aged seven to 18 years old, and a Day Activity Centre (DAC) for adults, aged 19 years and beyond.

In 2015, SAAC was appointed by the Ministry of Social and Family Development (MSF) to co-develop and operate Singapore's first autism home which is slated to be ready in 2018. It will be situated in Sengkang, with a co-located DAC.

While MSF will build the home, SAAC will largely be responsible for furnishing and

equipping it (estimated to cost S\$1.8 million) and its subsequent operational costs.

SAAC is non-profit and seeks to enable people with autism to lead dignified and meaningful lives; enriching lives. It is a service of St. Andrew's Mission Hospital.
